The CIFA candidates will be tested on accounting topics in conformity with the IFRS (International Financial Reporting Standards) and based on their accounting knowledge and practical skills.

The ICBC sponsors the Certified International Financial Accountant and Certified Business Consultant programs.

## **How to Become CIFA**

To become a CIFA, a candidate must fulfill the following requirements:

- Maintain continuous active membership with the ICBC
- Pass the CIFA examination passing grade is at least 70 out of 100
- At least two years' experience in accounting or other related fields –
  i.e. audit, finance, investment, business consultancy, and economic
  research.
- Fulfill the requirements of the CPE (Continuous Profession Education) program of the CIFA.

# **CIFA Training Programs**

CIFA Training Program could be planned over a timeframe of:

- 10 sessions 3 hours each; or,
- 5 days 6 hours each

The Program will be provided by professional instructors. It will cover the course material of the CIFA, sample Q&A, and other study related documents/papers.

The ICFC offers an educational program leading to the designation of Certified Professional Forensic Accountant - CPFAcct, and sponsors the Certified Professional Internal Auditor program.

## **How to Become CPIA**

To become a CPIA, a candidate must fulfill the following requirements:

- Be a member of the IFCA.
- Be a university graduate with Bachelor's degree.
- Pass the Certification exam, which comprises of 125 multiple-choice questions – the passing grade is at least 50%.

- 8 sessions 3 hours each; or,
- 4 days 6 hours each

The Program will be provided by professional instructors. It will cover the course material of the CPIA, sample Q&A, and other study related documents/papers.

The Certified Merger and Acquisition Specialist (CMAS) designation is a designation for professionals who participate in merger and acquisition transactions. CMAS addresses different phases of a merger and acquisition transaction, including:

- · Planning and searching
- Pre-acquisition activities, i.e. due diligence and valuation
- · Negotiation and closing
- Post-acquisition activities, i.e. integration

- Hold at least a bachelor degree
- Possess at least two years of experience in fields related to merger and acquisition activities
- Complete a 30 hours training program of CMAS from accredited providers by the IFC
- Pass an examination by having at least 70 correct answers out of 100 multiple choice questions
